

#### President's Corner



Our January meeting set a high standard for 2022! We had 70 people in the room to hear District Attorney General Amy Weirich and City Councilman Worth Morgan. Our First VP in charge of Programs, Judy Pearson, had a great idea. Instead of candidates giving speeches, Cary Vaughn, Chairman of the Republican Party of Shelby County, asked each candidate questions. They were not easy questions; however, they elicited information, incite, vision, and energy

General Weirich told us that what she is most proud of is when she is approached by someone who tells her, "You prosecuted me years ago and because you did, I am still alive. If you had not said,'Enough is enough,' I might be dead also." She developed the Community Justice Program to hold offenders accountable and to restore communities. Instead of six months in jail, the drug addict gets the help he needs to keep his record clean and to discontinue victimizing his neighborhood.

Councilman Worth Morgan told us that his biggest challenge is bringing people together at one table for the common good. He is looking for people who are in it for the right reason to sit at that table. He believes "We deserve better." That includes the people in the suburbs.

Our February meeting will focus on six judicial candidates. This second program of the year will continue being informative and energizing, creating another must-attend presentation for you.

## Election Information...

Tennessee Elections are an example of the Good Book edict: a time and place for everything. Our TN Elections also reflect the importance of following the rules.

TN laws are specific in regarding each and every detail of elections from placement on ballots to election times and days. Notions sometimes popup that "they" hid a candidate's name to make voting difficult or that placement is wrong. This notion is absolutely not true. Everything pertaining to elections in TN is reviewed/approved at the state level and governed by TN law. Presidential elections are held in even-numbered years

Presidential elections are held in even-numbered years (2020, 2024,2028) alternating with gubernatorial elections (2022,2026,2030). U.S. and State Representatives are elected in all those years.

Ballot-order places the highest ranking Federal candidates for that election at the top of the ballot. This placement is followed by ranking state officials. So top to bottom: President, Governor, U.S. Senator, U.S. Representative, TN State Senator, TN State Representative, judges in-order of-rank, County offices (ranked by office), then municipal offices and issues.

U.S. Representatives serve 2-year terms, a Federal election is held every two years with a primary in August and a general election in November. U.S. Senators serve 6-year terms; TN Senators serve 4-year terms. Judges serve 8-year terms. (No primary elections for judges.) This cycle will create a very large August 2022 ballot.

Registered votes who fail to vote in two Federal Elections are designated "inactive". This designation does not prohibit their voting unless failure to vote or to contact the Election Commission continues for two additional Federal elections. Voters have the responsibility to know and to follow the rules. See that you are properly registered, know your precinct, and know who

Voters have the responsibility to know and to follow the rules. See that you are properly registered, know your precinct, and know who are running for positions for which you can vote. Take proper photo ID with you to vote. All the information you need can be found at shelbyvote.com or GoVoteTN. Redistricting is underway. Review your mail. If your district changes, you will receive a notice from the Election Commission.


